## Rules and Regulations

By signing this Winery Application Form, I accept the Wine Discovery New Zealand 2010 Rules (listed below):

1. Participation is limited to 50 wineries. If we receive more applications for registration than we have space for, the Conference organisers will decide on the allocation of space.
2. If your application is unsuccessful then your deposit will be refunded. If your application is accepted the deposit is non-refundable.
3. The Conference organisers will appoint a tasting panel for the purpose of selecting wines to participate in the Conference. The tasting panel will select wines for participation in the Conference at their absolute discretion. The decision of the tasting panel is final and neither the Conference organisers nor the tasting panel is obliged to furnish reasons for its selection.
4. Participating wines must be wholly made, processed and matured in New Zealand by grape winemakers.
5. All participating wines must comply with all applicable legislative requirements relating to the composition and labelling of wine, including the Australia New Zealand Joint Food Standards Code, the Food Act 1981, the Food (Safety) Regulations 2002, the Wine Act 2003 and the Fair Trading Act 1986.
6. Complete winemaking records as recommended in the New Zealand Winegrowers Code of Practice must have been maintained for each participating wine.
7. All participating wines must be taken from, and be representative of, an homogeneous quantity of wine.
8. Entries are restricted to commercially bottled wines. Tank or barrel samples are not permitted.
9. The Conference is a highly prestigious event and participating wineries are expected to display a correspondingly high level of wine during the Conference. No second labels are permitted.
